



**FEES FOR SERVICES NOT COVERED BY OHIP**

**Message to Patients: Are you aware that not all of the services that we provide to you are insured through OHIP and that there is a charge for these services? These charges are established by the Ontario Medical Association and are reviewed on an annual basis.**

Sick notes for work and the copy/transfer of medical records are examples of these types of uninsured services. Providing these services requires time and resources and there is a cost for this.
